1. ISO27001 certification

Information security and cyber security are fundamental priorities at Trapets, and we continually develop and improve our information security management system (ISMS). Trapets has been certified under ISO 27001 since 2018.

Trapets leverages our ISO27001 certification as a foundation for meeting DORA requirements. During 2024, Trapets has transitioned to ISO27001:2023 and has successfully completed re-certification until 2027.

2. Gap analysis and implementation

DORA areas outside of ISO27001 are being worked on and implemented. This includes, but is not limited to:

- facilitating customer and prospect due diligence and audit of Trapets,
- updates to Trapets' risk, incident management and reporting processes,
- further improvements of operational resilience,
- close collaboration with sub-contractors, and updates to supplier evaluation and audit process
